



Terms and Conditions
BUSHMANS WINTER CASH BACK PROMOTION 2021
1 July 2021 – 31 August 2021

1. Offer is open to Australian residents only. The following are ineligible to claim:
 - (a) Employees of the Promoter (and the immediate families of the employees, i.e., spouse, ex-spouse, child, or stepchild (whether natural or adoption), parent, stepparent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister or first cousin), participating resellers and agencies associated with this promotion.
 - (b) Purchasers who are given a discount or special pricing (e.g., tenders, field days and other contracts) or government pricing.
 - (c) Purchasers of second quality and auction goods.
2. To be eligible, claimants must purchase a qualifying Bushmans tank from an authorised and participating reseller or direct from Bushmans within Australia between 1 July 2021 and 31 August 2021 (inclusive). The tank(s) must be delivered by September 30, 2021. The purchase date is determined by the date of purchase printed on the reseller's tax invoice submitted as proof of purchase.
3. Subject to validity of claim, claimants will receive the following cash-back amount inclusive of GST when they purchase the following tanks:

4. To Claim:
 - (a) purchase a Bushmans tank from a participating retailer during the promotional period.
 - (b) multiple entries will be accepted when multiple tanks are purchased.

2. Posted to *Bushmans Winter Cashback Promotion 2021*, GPO Box 4218, Sydney NSW 2001 or emailed to info@bushmans.com.au with *Bushman Winter Cashback Promotion 2021* in the subject heading.
 - a. Entrants must retain their original product purchase receipt(s) and tax invoice(s) for all entries as proof of purchase, (clearly specifying the store of purchase and the date of purchase). Failure to produce the proof of purchase for each entry when requested may, in the absolute discretion of the Promoter, result in invalidation of that entry or ALL of an entrant's entries and forfeiture of any right to a cash back. Purchase receipt(s) must clearly show that the purchase was made during the Promotional Period but prior to entry.
 - b. To make a valid claim, claimants must complete the claim with their tax invoice as proof of purchase attached regardless of route of entry (online or posted). The claim must be received by the promoter on or before September 30, 2021, entries received after this date will be deemed invalid. Incomplete, indecipherable, or illegible entries will be deemed invalid.
5. The promotion commences at 8.00 [EST] on July 1, 2021, and it closes at 18.00 [EST] on August 31, 2021 ("Promotional Period").
6. Any entries received by the Promoter on or after September 30, 2021, will be deemed invalid. Incomplete, indecipherable, or illegible entries will be deemed invalid.
7. The cash back amount will be issued by cheque drawn in favour of the claimant and mailed to the specified address of the claimant. Please allow 31 days from receipt and validation of the claim. It is the responsibility of the claimant to provide the correct details for the drawing and mailing of the cheque for the cashback payment.
8. The Promoter reserves the right, at any time, to verify the validity of claims (including contacting the place of purchase) and claimants (including a claimant's identity, age, and place of residence) and to disqualify any claimant who submits a claim that is not in accordance with these Terms and Conditions or who tampers with the claim process. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The claimant agrees that if they have obtained the cash back, they will pay back the Promoter within 14 days of demand the value of the cash back, if they subsequently return the tank to the place of purchase and seek a refund.

9. Multiple claims are permitted, subject to the following: (a) only one claim permitted per specified purchase requirement; and (b) each claim must be submitted in accordance with claim requirements.
10. If there is a dispute as to the identity of a claimant, the Promoter reserves the right, in its sole discretion, to determine the identity of the claimant.
11. The Promoter's decision is final, and no correspondence will be entered into.
12. If the claimant is under the age of 18 years, the cash back will be awarded to the claimant's nominated parent or guardian.
13. Claims and cashbacks are not transferable or exchangeable.
14. Claims cannot be made on back orders.
15. Except for any liability that cannot be excluded by law, the Promoter (including its officers, employees and agents) excludes all liability (including for negligence), for any personal injury; or any loss or damage (including loss of property); whether direct, indirect, special or consequential, arising in any way out of the promotion, including, but not limited to, where arising out of the following: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any claim or offer that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in the offer value to that stated in these Terms and Conditions; or (e) participation in the offer.
