

Terms and Conditions

Win a Tinny Bushmans Promotion 2026

1. Information on how to enter and details of the prize form part of these Terms and Conditions. By participating, entrants agree to be bound by these Terms and Conditions.
2. The “Promoter” is Bushmans Group Pty Limited (ACN 137 242 347), of 15 Cb Fisher Dr, Cavan SA 5094.
3. Entry to the promotion is open to all Australian Citizens and Residents aged 18 years and over who fulfil the entry requirements (“Eligible Entrants”).
4. Directors, management, employees, and their immediate families, of the Promoter, retailers, suppliers, associated entities, and agencies associated with this promotion are ineligible to participate.

5. How to Enter

To enter, Eligible Entrants must:

- a) Purchase any qualifying Bushmans, OzPoly and/or Aqualine tank from Bushmans directly or from an authorised and participating Bushmans reseller within Australia during the Promotional Period; and

- c) Submit an original written response of 100 words or less answering the following question:

“What would winning this tinny mean to you, and how would it fit into your Australian lifestyle?”

The purchase date is determined by the date shown on the tax invoice. Proof of purchase must be retained and may be requested for verification purposes.

6. Only one (1) entry is permitted per order, regardless of the number of tanks purchased in that order.

7. Game of Skill

This promotion is a game of skill. Chance plays no part in determining the winner. Each valid entry will be judged individually based on its merit.

Entries will be judged by a panel appointed by the Promoter and based on the following criteria:

The promotional period to purchase a water tank commences at 8:00am EST on 1 March 2026 and closes at 6:00pm EST on 31 August 2026 ("Promotional Period").

10. Entries must be received by 11:59pm AEST on 30 September 2026.

11. Entries will be judged by a panel appointed by the Promoter and will take place at 15 Cb Fisher Drive, Cavan SA 5094 within 10 business days of entries closing, and no later than 14 October 2026.

14. Prize Details & Delivery

The prize is one (1) aluminium tinny boat package, which includes:

one (1) Trekker VBP 385 aluminium tinny boat;
one (1) Mercury 9.9hp motor; and
one (1) trailer.

The total prize value is up to \$11,500 AUD (RRP).

The prize will be made available to the winner within 10 weeks of winner confirmation, subject to availability and logistics. Delivery location must be within SA, VIC, ACT, QLD and NSW.
